## Submitting Entries

All prints must be delivered to the YMCA office at 383 N 3<sup>rd</sup> Avenue, Stayton OR 97383, by 1pm July 19<sup>th</sup> 2008. The YMCA office is open 10am-5pm Tues-Fri and 9am-1pm Saturdays. Contact [staytonevents.com](http://staytonevents.com) if after hour delivery is needed.

## Jurying

A panel of three jurors will score all submitted prints on a 1-9 scale. Prints chosen for exhibition will be determined by initial score ranking and Gallery space capacity. The jurors will then select all award winners except "People's Choice" award.

## Awards

Jurors will award ribbons for First, Second and Third place prints in both Monochrome and Color Divisions. High scoring prints will receive an Honorable Mention ribbon. A special ribbon award will also be given to the print best representing "Scenic Santiam". A People's Choice award will be selected by viewers during SummerFest.

## Rules

1. All images must be the original work of the submitter. By virtue of submitting an entry, entrants certify the work as their own. The exhibition assumes no liability for any misrepresentation or misuse of copyright material.
2. A maximum of three prints may be entered in each of two Divisions, Monochrome/B&W or Color.
3. Digital prints may not contain non-photographic elements.
4. Prints must be mounted securely on a rigid, lightweight backing (mat board, foam-core, or cardboard).
  - No wood, masonite or heavy dense mat board.
  - No frames or glass covered
  - No hanging devices or other protrusions on the back or front of mounted prints.
5. The overall dimension of the matted or mounted print must be at least 8 x 10 inches, not to exceed 16 x 20 inches.
6. **No information allowed on front of entry.**
7. The following information **must** be on the back of each entry.
  - Entrants name and address
  - Title of print
  - Corresponding print number from entry form
  - Location, if considered for theme award
8. All prints, completed entry form and entry fee must be received by 1pm Saturday, July 19.
9. Images previously published in a locally circulated publication are ineligible.

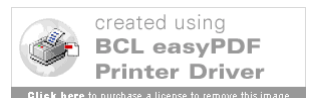
